#### 1. Overview

We invite Expressions of Interest (EOI) for the planning and establishment of New Sugar Plant and refinery along with complete operation of the plants for a specified duration. Proposed plants shall be equipped with cutting-edge technology, optimized for energy efficiency and reduced steam consumption.
