SECTION I: INSTRUCTIONS TO BIDDERS (ITB)

(A) THE BID DOCUMENT

1-Cost of e-Bid

- a) The bidder shall bear all costs associated with the preparation and submission of its e-Bid and Ramala Sahkari Chini Mills ltd, Ramala (Baghpat) hereinafter referred to as "the Purchaser", will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the e-Bid process.
- b) This tender document is available on the web site http://etender.up.nic.in and www.upsugarfed.org to enable the bidders to view, download the e-Bid document and submit e-Bids online up to the last date and time mentioned in e-Tender notice/e-tender document against this e-Tender. The bidders shall have to pay e-Tender document fee of Rs 590.00 (Rupees Five hundred Ninety rupees Only) in cash or through RTGS/ NEFT in favour of RAMALA COOP SAHKARI CHINI MILL, payable at RAMALA. The scanned copy of the Cash Deposit Receipt or proof of RTGS (UTR No.) must be enclosed along with the e-Bid but the original Cash Deposit Receipt or proof of RTGS (UTR No.) should be submitted to the e-Tender Committee at e-Bid opening place before opening of the technical e-Bid. 2.2 The bidder is expected to examine all instructions, forms, terms and specifications in the e-Bid document. Failure to furnish all informations required as per the e-Bid document or submission of e-Bid not responsive to the e-Bid document in every respect will be at the bidder's risk and may result in rejection of the said e-Bid.

3-Clarification of e-Bid Document

4. Amendment of e-Bid Document

- 4.1 At any time prior to the deadline for submission of e-Bid, the Sugar Mill may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the e-Bid document by amendments. Such amendments shall be uploaded on the e-Procurement website http://etender.up.nic.in and Purchaser's web site www.upsugarfed.org through corrigendum and shall form an integral part of e-Bid document. The relevant clauses of the e-Bid document shall be treated as amended accordingly.
- 4.2 It shall be the sole responsibility of the prospective bidders to check the web site http://etender.up.nic.in and www.upsugarfed.org from time to time for any amendment in the e-tender document. In case of failure to get the amendments, if any, the Sugar Mill shall not be responsible for it.
- 4.3 In order to allow prospective e-Bidders a reasonable time to take the amendment into account in preparing their e-Bids, the Sugar Mill, at his discretion, may extend the deadline for the submission of e-Bids. (B) PREPARATION OF e-Bid

5 Language of e-Bid

5.1 The e-Bid prepared by the bidder, as well as all correspondence and documents relating to the e-Bid exchanged by the bidder and the Purchaser shall be written either in English or Hindi language. The correspondence and documents in Hindi must be accompanied by embedded/separate Hindi font files. Only English numerals shall be used in the e-Bid.

6 Documents Constituting the e-Bid

- 6.1 The e-Bid prepared by the bidder shall comprise the following components:
- (a) **Technical e-Bid** Technical e-Bid will comprise of:
- (i) <u>Fee Details</u> includes copies of e-tender document processing/Cost and e-Bid Earnest Money Deposit furnished in accordance with ITB Clause 12 in PDF format.
- (ii) Qualification Details includes copies of required documents as per ITB Clauses 10 and 11 in PDF format justifying that the bidder is qualified to perform the contract if his/her bid is accepted and that the bidder has financial, technical and production capability necessary to perform the contract and meets the criteria outlined in the Qualification Requirement and Technical Specification and fulfill all the conditions of the Contract and that the goods and ancillary services to be supplied by the bidder conform to the e-Bid document and Technical Specifications.

8 e-Bid Price

- 8.1 The bidder shall quote separately in the downloaded spread sheet file for the Price of Cane Transport to be supplied to Mill.
- 8.2 The price of Cane Transport including all duties, gst and other taxes already paid.
- 8.3 Prices quoted by the bidder shall be fixed during the bidder's performance of the Contract and not subject to variation on any account subject to ITB Clause 25.1. A e-Bid submitted with an adjustable price quotation unless asked for shall be treated as non-responsive and rejected.

9 e-Bid Currencies

Prices shall be quoted in Indian Rupees only.

10 Documents Establishing bidder's Qualification

10.1 Pursuant to ITB Clause 6, the bidder shall furnish, as part of its Technical e-Bid, documents establishing the bidder's qualification to perform the Contract if its e-Bid is accepted. The documentary evidence should be submitted by the bidder electronically in the PDF format.

The documentary evidence of bidder's qualification to perform the Contract if its e-Bid is accepted shall be as per Qualification Requirements specified in Section III (D) of e-tender document.

11 Documents Establishing Cane Transport Conformity to e-Bid Documents

11.1 Pursuant to ITB Clause 6, the bidder shall furnish, as part of its e-Bid, documents establishing the conformity to the e-Bid documents of all goods and services which the bidder proposes to supply under the contract. The documentary evidence should be in the PDF file format.

e-Bid Earnest Money Deposit (EMD)

Pursuant to ITB Clause 6, the bidder shall furnish, as part of its e-Bid, an e-Bid EMD of (as per detail at page no. 1) through RTGS/ NEFT in favour of RAMALA COOP SAHKARI CHINI MILL, payable at RAMALA. The scanned copy of [rppf pf RTGS (UTR No.) of e-Bid EMD must be submitted along with the e-Bid and the original should be submitted to the e-Tender Committee at e-Bid opening place before opening of technical e-Bid. No Interest on EMD will be paid.

- 12.2 The e-Bid E.M.D is required to protect the Mill against the risk of bidder's conduct which would warrant the E.M.D's forfeiture, pursuant to ITB Clause 12.7.
- 12.3 The e-Bid E.M.D shall be in Indian Rupees and shall be in the following forms only:
 - A Demand Draft payable in favour of Ramala Sahkari Chini Mills Ltd., payable at Ramala (Baghpat) OR Baraut(Baghpat).
- 12.4 Any e-Bid not secured in accordance with ITB Clauses 12.1 and 12.3 above shall be treated as non-responsive and rejected by the Mill.
- 12.5 Unsuccessful bidder's e-Bid E.M.D will be returned upon the written request through cheque as promptly as possible.

12.6 The e-Bid E.M.D may be forfeited:

- (a) if a bidder (i) withdraws its e-Bid during the period of e-Bid validity specified by the bidder on the e-Bid Form; or (ii) does not accept the correction of errors pursuant to ITB Clause 22.2; or (iii) modifies its e-Bid price during the period of e-Bid validity specified by the bidder on the e-Bid form or
- (b) In case of a successful bidder, if the bidder fails:
- (i) To sign the Contract with the Mill in accordance with ITB Clause 28; or
- (ii) To furnish performance security in accordance with ITB Clause 29.

13 Period of Validity of e-Bid

- 13.1 E-Bid shall remain valid up to 45 days and the Rate contract for the period up to June 2024. An e-Bid valid for a shorter period shall be rejected by the Mill as non-responsive.
- 13.2 In exceptional circumstances, the Mill may solicit the bidder's consent to an extension of the period of e-Bid validity. The request and the response thereto shall be made in writing. A bidder may refuse the request without forfeiting its e-Bid security. A bidder granting the request will not be required nor permitted to modify its e-Bid.

14 Format and Signing of e-Bid

- 14.1 The bidder shall prepare one electronic copy each of the Technical e-Bid and Financial e-Bid separately.
- 14.2 The e-Bid document shall be digitally signed, at the time of uploading, by the bidder or a person or persons duly authorized to bind the bidder to the Contract. The letter of authorization shall be indicated by a scanned copy of written power-of-attorney accompanying the e-Bid. All the pages/ documents of the e-Bid that are to be uploaded shall be digitally signed by the person authorized to sign the e-Bid.

15. Submission of e-Bid

The Bid Submission module of e-Procurement website http://etender.up.nic.in enables the bidders to submit the e-Bid online in response to this e-tender published by the Mill. Bid Submission can be done only from the Bid Submission start date and time till the Bid Submission end date and time given in the e-tender. Bidders should start the Bid Submission process well in advance so that they can submit their e-Bid in time. The bidders should submit their e-Bid considering the server time displayed in the e-Procurement website. This server time is the time by which the e-Bid submission activity will be allowed till the permissible time on the last/end date

of submission indicated in the e-tender schedule. Once the e-Bid submission date and time is over, the bidders cannot submit their e-Bid. For delay in submission of e-Bid due to any reasons, the bidders shall only be held responsible.

The bidders have to follow the following instructions for submission of their e-Bid:

- 15.1 For participating in e-Bid through the e-tendering system, it is necessary for the bidders to be the registered users of the e-Procurement website http://etender.up.nic.in. The bidders must obtain a User Login Id and Password by registering themselves with U.P. Electronics Federation Limited, Lucknow if they have not done so previously for registration. Refer to details given in Invitation for e-Bid Clause 10.
- 15.2 In addition to the normal registration, the bidder has to register with his/her **Digital Signature Certificate (DSC)** in the e-tendering system and subsequently he/she will be allowed to carry out his/her e-Bid submission activities. Registering the Digital Signature Certificate (DSC) is one time activity. Before proceeding to register his/her DSC, the bidder should first log on to the e-tendering system using the User Login option on the home page with the Login Id and Password with which he/ she has registered as per clause 15.1 above.

After entering and saving the Tender Fee and EMD details, the bidder should click "Encrypt & Upload" option given in the offline payment details form so that "Bid Document Preparation and Submission" window appears to upload the documents as per Technical (Fee details, Qualification details, e-Bid Form and Technical Specification details) and financial (e-Bid Form and Price Schedule/BOQ) schedules/packets given in the tender details. The details of the Demand Draft or any other accepted instrument which is to be physically sent in original before opening of technical e-Bid, should tally with the details available in the scanned copy and the data entered during e-Bid submission time otherwise the e-Bid submitted will not be accepted.

- 15.5 Next the bidder should upload the Technical e-Bid documents for Fee details (etender fee and EMD), Qualification details as per "ITB Clause 10 or 21", e-Bid Form as per "Section-III(A)" and Technical Specification details as per "Section-III(C):Technical Specifications" and Financial e-Bid documents as per "Section-IV(A):e-Bid Form" and "Section-IV(B):Price Schedule/BOQ" of e-tender document. Before uploading, the bidder has to select the relevant Digital Signature Certificate. He may be prompted to enter the Digital Signature Certificate password, if necessary. For uploading, the bidder should click "Browse" button against each document label in Technical and Financial schedules/packets and then upload the relevant PDF/XLS files already prepared and stored in the bidder's computer. The required documents for each document label of Technical (Fee details, Qualification details, e-Bid Form and Technical Specification details) and financial (e-Bid Form and Price Schedule/BOQ) schedules/packets can be clubbed together to make single different files for each label.
- 15.6 The bidder should click "Encrypt" next for successfully encrypting and uploading of required documents. During the above process, the e-Bid documents are digitally signed using the DSC of the bidder and then the documents are encrypted/locked electronically with the DSC's of the bid openers to ensure that the e-Bid documents are protected, stored and opened by concerned bid openers only.
- 15.7 After successful submission of e-Bid document, a page giving the summary of e-Bid submission will be displayed confirming end of e-Bid submission process. The bidder can take a printout of the bid summary using the "Print" option available in the window as an acknowledgement for future reference.
- 15.8 Mill reserves the right to cancel any or all e-Bids without assigning any reason.

16-Deadline for Submission of e-Bid

- e-Bid (Technical and Financial) must be submitted by the bidders at e-Procurement website http://etender.up.nic.in not later than time 11:00A.M. and 12/09/2024 the date as mentioned on page 4 (as the server time displayed in the e-Procurement website).
- 16.2 The Mill may, at its discretion, extend this deadline for submission of e-Bid by amending the e-Bid document in accordance with ITB Clause 4, in which case all rights and obligations of the Mill and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

17 Late e-Bid

17.1 The server time indicated in the Bid Management window on the e-Procurement website http://etender.up.nic.in will be the time by which the e-Bid submission activity will be allowed till the permissible date and time scheduled in the e-tender. Once the e-Bid submission date and time is over, the bidder cannot submit his/her e-Bid. Bidder has to start the Bid Submission well in advance so that the submission process passes off smoothly. The bidder will only be held responsible if his/her e-Bid is not submitted in time due to any of his/her problems/faults, for whatsoever reason, during e-Bid submission process.

18 Withdrawal and Resubmission of e-Bid

- 18.1 At any point of time, a bidder can withdraw his/her e-Bid submitted online before the bid submission end date and time. For withdrawing, the bidder should first log in using his/ her Login Id and Password and subsequently by his/her Digital Signature Certificate on the e-Procurement website http://etender.up.nic.in. The bidder should then select "My Bids" option in the Bid Submission menu. The page listing all the bids submitted by the bidder will be displayed. Click "View" to see the details of the e-Bid to be withdrawn. After selecting the "Bid Withdrawal" option, the bidder has to click "Yes" to the message "Do you want to withdraw this bid?" displayed in the Bid Information window for the selected bid. The bidder also has to enter the bid Withdrawing reasons and upload the letter giving the reasons for withdrawing before clicking the "Submit" button. The bidder has to confirm again by pressing "Ok" button before finally withdrawing his/her selected e-Bid.
- 18.2 The bidder has to request the Mill with a letter, attaching the proof of withdrawal and submission of e-Bid EMD in the office of Mill, to return back the e-Bid security/EMD as per the manual procedure.
- 18.3 No e-Bid may be withdrawn in the interval between the deadline for submission of e-Bids and the expiration of period of e-Bid validity. Withdrawal of an e-Bid during this interval may result in the bidder's forfeiture of his/her e-Bid E.M.D, pursuant to ITB Clause 12.7.
- 18.4 The bidder can re-submit his/her e-Bid as and when required till the e-Bid submission end date and time. The e-Bid submitted earlier will be replaced by the new one. The payment made by the bidder earlier will be used for revised e-Bid and the new e-Bid submission summary generated after the successful submission of the revised e-Bid will be considered for evaluation purposes. For resubmission, the bidder should first log in using his/her Login Id and Password and subsequently by his/her Digital Signature Certificate on the e-Procurement website http://etender.up.nic.in. The bidder should then select "My Bids" option in the Bid Submission menu. The page listing all the bids submitted by the bidder will be displayed. Click "View" to see the details of the e-Bid to be resubmitted. After selecting the "Bid Resubmission" option, click "Encrypt & Upload" to upload the revised e-Bid documents by following the methodology provided in clauses 15.4 to 15.7.
- 18.5 The bidders can submit their revised e-Bids as many times as possible by uploading their e-Bid documents within the scheduled date & time for submission of e-Bids.
- 18.6 No e-Bid can be resubmitted subsequently after the deadline for submission of e-Bids.

(C) e-Bid OPENING AND EVALUATION OF e-Bid

19(A) Opening of Technical e-Bid by the Mill

19.A-1 The Mill will open all technical e-Bids, in the presence of bidders' representatives who choose to attend at 11:00 AM on 12/09/2024 at Ramala Sahkari Chini Mills Ltd.,Ramala (Baghpat) The bidder's representatives who are present shall sign a register evidencing their attendance. In the event of the specified date of e-Bid

- opening being declared a holiday for the Mill, the e-Bids shall be opened at the appointed time and place on the next working day.
- 19.A-2 The bidder's names and the presence or absence of requisite e-Bid security and such other details as the Mill at its discretion may consider appropriate, will be announced at the opening. The name of such bidders not meeting the Technical Specifications and qualification requirement shall be notified subsequently.
- 19.A-3 The Mill will prepare minutes of the e-Bid opening.
- 19 A-4 General Manager reserves the right to postpone the date and time of opening of Technical & Financial E-Bid in unavoidable circumstances and all the bidders will be informed.

19(B) Opening of Financial e-Bid

- 19B-1 After evaluation of technical e-Bid, the Mill shall notify those bidders whose technical e-Bids were considered non-responsive to the Conditions of the Contract and not meeting the technical specifications and Qualification Requirements indicating that their financial e-Bids will not be opened. The Mill will simultaneously notify the bidders, whose technical e-Bids were considered acceptable to the Mill. The notification may be sent by letter, fax or by e-mail.
- 19B-2 The financial e-Bids of technically qualified bidders shall be opened on 12/09/2024 at 03:00 P.M in the presence of bidders who choose to attend the opening of financial bid. The name of bidders, Unit Price quoted for various items etc will be announced at the meeting.
- 19B-3 The Mill will prepare the minutes of the e-Bid opening.

20 Clarification of e-Bid

20.1 During evaluation of e-Bid, the Mill may, at its discretion, ask the bidder for a clarification of his/her e-Bid. The request for clarification and the response shall be in writing.

21 Evaluation of technical e-Bid and Evaluation Criteria

The Mill will examine the e-Bid to determine whether they are complete, whether they meet all the conditions of the Contract, whether required e-tender fee, e-Bid EMD and other required documents have been furnished, whether the documents have been properly digitally signed, and whether the e-Bids are generally in order. Any e-Bid or e-Bids not fulfilling these requirements shall be rejected.

The bidders shall submit the scanned copies of following as documentary proof for evaluation of their technical e-Bids:-

21.1 The e-Bid submitted without required documentary proof shall be rejected.

- 1. The tenderer has to submit earnest money (as per detail at page no. 1) by demand draft of any Nationalised/Scheduled Bank in favour of Ramala Sahkari Chini Mills Ltd.,Ramala (Baghpat) OR Baraut(Baghpat) The. The scanned copy of EMD should be uploaded with tender for Cane Transport Tenderer must have registration in the Sales Tax Department/GST & has to submit TIN issued by the department.
- 2. Tenderer must have registration in the Central Excise Department & has to submit Registration Certificate.
- 3. Tenderer must have registration in the Income Tax Department & has to submit copy of PAN/GST no.
- 4. Incase, tenderer has supplied Cane Transport to other Mills/Industries, copies of orders should be submitted as a proof of Cane Transport
- 21.4 It shall be the discretion of the Purchaser to decide as to whether an e-Bid fulfils the evaluation criterion mentioned in this e-tender or not.
- 21.5 The bidders are advised not to mix financial bid documents with the PDF documents submitted for technical bid. The e-Bids of the bidders having financial bid document in the technical bid will out rightly are rejected.

22 Financial Evaluation and Comparison of e-Bid

- 22.1 The Mill will evaluate and compare the financial rates of individual items quoted in the price schedule/BOQ of e-Bids of those bidders whose technical e-Bids are found responsive as per the conditions of the e-tender only for those items of the bidders which have been technically accepted by the Mill.
- 22.2 No additional payments shall be made for completion of any contractual obligation beyond the quoted prices. If the supplier does not accept the correction of errors if any, its e-Bid shall be rejected and its e-Bid security may be forfeited.
- 22.3 No weightage/preference shall be given to the bidder quoting any higher technical specifications against the technical specifications of the items asked in the e-tender.
- 22.4 The Mill's evaluation of a financial bid shall be based in terms of lowest rate quoted including all taxes, duties & other expenses.
- 22.5 The Financial Bids will be opened by Tender Evaluation committee (TEC) in the presence of Bidders" representatives (only one) who choose to attend the Financial Bid opening on date and time to be communicated to all the technically qualified Bidders. The Bidder's representatives who are present shall sign a register evidencing their attendance.

The name of Bidder, Bid Prices etc shall be announced at the meeting.

The commercial quotes of the lowest Bidder shall be notified as L-1. The Quantity offered by the L-1 shall be first taken into consideration.

The bidders are required to give their lowest rates in the tenders, though, generally negotiation will not be held but if required then it will be done with the lowest bidder (L-1) unit wise.

a) In case L-1 offers to supply the complete order quantity and is assessed to have the adequate capacity to supply the complete order quantity as per the delivery schedule

- b) by the Tender Evaluation committee (TEC) then L-1 shall be contracted to execute the complete supply order.
- c) In case L-1 offers to supply partial order quantity and is assessed to have adequate capacity to supply the offered partial order quantity as per the delivery schedule by the Tender Evaluation committee (TEC) then the L-1 bidder shall be contracted to supply the reduced quantity (which shall be more than the guaranteed minimum quantity) and rest of the quantity shall be allotted to subsequent bidder(s) provided the successful Bidder(s) are ready to offer the quantity at the rates quoted by L-1.
- d) The quantity resulting from the split as mentioned above in case (b) shall be offered to the successful Bidder(s) after the assessment by the TEC in terms of their capacity to manufacture and supply.
- e) In case L-1 backs out, the RFP shall be cancelled & Bids shall be invited again L-1 shall however be blacklisted from participating in any future bidding and are liable for legal action taken by the MILL Society.

23. Contacting the mill.

- 23.1 Subject to ITB Clause 20, no bidder shall contact the mill on any matter relating to his/her e-Bid, from the time of the e-Bid opening to the time the Contract is awarded. If the bidder wishes to bring additional information to the notice of the mill, he/she can do so in writing.
- Any effort by a bidder to influence the Mill in its decisions on e-Bid evaluation, E-Bid comparison or contract award may result in rejection of the bidder's e-Bid.

(D) AWARD OF CONTRACT

24 Award Criteria

- 24.1 The mill will determine to its satisfaction whether the bidder(s) that is selected as having submitted the lowest rate (L-1) evaluated responsive bid meets the criteria specified in ITB Clause 10.2, and is qualified to perform the contract satisfactorily.
- 24.2 Subject to ITB Clause 26, the Mill will award the contract to the lowest rate (L-1) evaluated successful Bidder whose bid has been determined to be responsive to all the conditions of the contract and meeting the Technical specification and qualification requirement of the Bidding Document.

25 Mill's right to vary Quantities at the Time of Award

- The mill reserves the right at the time of Contract award to increase or decrease the quantity of goods and services originally specified in the Schedule of Requirements without any change in unit price or other terms and conditions, depending upon the requirement of end-customer. The purchaser may also increase or decrease the quantity even after award of contract up to the validity period of E-bid.
- 25.2 If any taxes/duties are increased/ decreased by the Government during the contract period, the same shall be adjusted mutually after submitting the proof by the successful bidder to the Mill.

26 Mill's right to accept any E-Bid and to reject any or all e-Bids

26.1 The General Manager reserves the right to accept or reject any E-Bid, and to annul the e-Bid process and reject all e-Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

27-Notification of Award

27.1 Prior to the expiration of the period of e-Bid validity, the mill will notify the successful bidder in writing by letter/e-mail/fax that his/her e-bid has been accepted.

28 Signing of Contract

- 28.1 At the same time as the mill notifies the successful bidder that his e-bid has been accepted, the mill will send the bidder the work order/contract form provided in the e-bid document, incorporating all conditions of the agreement between the parties i.e. mill & successful bidder.
- 28.2 Within 07 days of receipt of the contract form, the successful bidder shall execute, Sign & date the work order/contract & returned it to the Mill.

SECTION II: CONDITIONS OF E-Tender/CONTRACT

Only Experienced Contractor fulfilling the required conditions of tender document are eligible to participate in the tender.

- 1. गन्ना क्रय केन्द्र पर गन्ने की किसी भी साधन से क्रय की गयी मात्रा को उतरवाकर क्रय केन्द्र पर प्लाट में चट्टा लगाना तथा चट्टे से अपने मजदूरों एवं लोडर से गन्ना ट्रक में भरवाकर मिल के कैन कैरियर तक लाना होगा। तोल तिथि में खरीदे गये गन्ने की पूर्ण मात्रा को उसी दिन मिल गेट तक लाना होगा।
- 2. निर्धारित समय से अधिक समय तक गन्ना क्रय केन्द्र पर पड़े रहने पर परिवहन ठेकेदार को बैलेन्स रहे गन्ने पर अनुबन्ध में उल्लिखित शर्तों के अनुसार निर्धारित जुर्माना देना होगा। यदि फिर भी ट्रांसपोर्टर उक्त गन्ने की मात्रा को निर्धारित समय तक मिल गेट तक नहीं पहुंचाता है तो मिल प्रबन्धन को पूर्ण अधिकार होगा कि इस मात्रा की ढुलाई करवाकर इस पर हुए समस्त व्यय को सम्बन्धित परिवहन ठेकेदारों के बिलों से समायोजित कर लिया जाएगा।
- 3. निविदा स्वीकार होने के बाद तथा अनुबन्ध पत्र पर दोनों पक्ष के हस्ताक्षर होने के बाद ही सत्र 2024–25 की अविध के लिये ठेका मान्य होगा। निर्धारित दर सामान्य रूप से नहीं बदली जायेगी।
- 4. क्रय केन्द्र पर गन्ना ढुलाई एवं ट्रकों में लदाई हेतु लेबर/लोडर का प्रबन्ध गन्ना परिवहन ठेकेदार को स्वयं करना होगा।
- 5. गन्ना ढुलाई का कार्य रात-दिन करना होगा तथा क्रय केन्द्र पर प्रकाश आदि की व्यवस्था स्वयं गन्ना परिवहन ठेकेदार को करनी होगी।
- 6. गन्ना ढुलाई दर लेबर सहित देनी होगी।
- 7. किसी भी स्थिति में मिल प्रबन्धन को यह महसूस होता है कि गन्ने की लदाई, उतराई, ढुलाई की व्यवस्था असन्तोषजनक है तो मिल प्रबन्धन को स्थाई या अस्थाई जैसी भी स्थिति हो, अतिरिक्त गाड़ियां व मजदरों को क्रय केन्द्र पर लगाने का पूर्ण अधिकार होगा। इस प्रकार से मिल प्रबन्धन द्वारा दिये गये भुगतान को ठेकेदार के बिलों से काटने का पूर्ण अधिकार होगा। ऐसा प्रकरण संज्ञान में आने पर उसकी धरोहर धनराशि को जब्त करते हुए कार्यवाही की जायेगी।
- 8. मिल प्रबन्धन यदि यह आवश्यक समझे कि एक क्रय केन्द्र से गाड़ी व मजदूर/लोडर दूसरे क्रय केन्द्र पर भेजने हैं तो दूसरे क्रय केन्द्र पर गाड़ी व मजदूरों/लोडर को भेज सकते हैं तथा भेजे गये ट्रकों तथा मजदूरों/लोडर का भुगतान उसी क्रय केन्द्र की परिवहन दर से सम्बन्धित गन्ना परिवहन ठेकेदार द्वारा बिल प्रस्तुत करने पर किया जायेगा।
- 9. यदि मिल प्रबन्धन की दृष्टि में गन्ना ढुलाई मय लदाई का कार्य संतोषजनक नहीं पाया जाता है तथा सम्बन्धित गन्ना परिवहन ठेकेदार को लिखित चेतावनी देने के उपरान्त भी मिल प्रबन्धन की दृष्टि में संतोषजनक सुधार नहीं होता है तो मिल प्रबन्धन को पूर्ण अधिकार होगा कि इस अनुबन्ध को दो दिन का नोटिस देकर समाप्त कर दे। इसकी लिखित सूचना ठेकेदार को अथवा उसके किसी चालक को या परिचालक को सर्व कर दी जायेगी तथा एक प्रति सम्बन्धित क्रय केन्द्र पर चस्पा कर दी जायेगी।
- 10.निविदादाता गन्ना ढुलाई हेतु अपने पास उपलब्ध स्वयं के ट्रकों के व्यावसायिक पंजीयन प्रमाण पत्र सिहत ई-निविदा ऑन-लाईन अपलोड़ करेगे।
- 11. गन्ना लदाई, ढुलाई का पाक्षिक बिल गन्ना परिवहन ठेकेदार द्वारा गन्ना कार्यालय में प्रत्येक माह की 17 एवं 2 तारीख को देना होगा। बिल मिल गेट पर प्राप्त गन्ने से जूना कर्दा काटकर शुद्ध गन्ने का बिल बनाना होगा।
- 12. माह के प्रथम पक्ष का भुगतान दिनांक 23 तारीख तक तथा द्वितीय पक्ष के बिलों का भुगतान माह की 8 तारीख तक किया जायेगा।
- 13.अंतिम बिल का भुगतान एक माह के बाद समस्त औपचारिकता पूर्ण होने पर किया जायेगा।

- 14. ठेकेदार एवं उसके कर्मचारियों, चालक, परिचालक को मिल के अधिकारियों एवं गन्ना कर्मचारियों द्वारा दिये गये निर्देश, गन्ना उतराई, केन्द्र पर ट्रक पहुंचाने की दशा में चट्टा लगाई, क्रय केन्द्रों से सम्बन्धित सूचना लाने व ले जाने तथा अन्य क्रय केन्द्रों से किसी भी निर्देशों के पालन न करने की स्थिति में या नियम तोड़ने की दशा में अभद्रता या हड़ताल करने का चीनी मिल समिति को क्षति पहुंचाने की स्थिति में किसी भी हानि के लिये मिल प्रबन्धन को अधिकार होगा कि उसकी क्षति पूर्ति / हर्जाना गन्ना परिवहन ठेकेदारों के बिलों से या जमानत से कर लें।
- 15. ठेकेदार अथवा उसके द्वारा रखे गये मजदूर/चालक/ परिचालक अथवा किसी कर्मचारी को क्रय केन्द्र अथवा मिल क्षेत्र में मादक पदार्थों के प्रयोग की अनुमित नहीं होगी । इस धारा का उल्लंघन करने पर प्रधान प्रबन्धक को अनुबन्ध को समाप्त करने का पूर्ण अधिकार होगा तथा जुर्माना भी किया जा सकता है।
- 16.ट्रक खाली होते समय चालक अथवा परिचालक की उपस्थिति अनिवार्य होगी, जिससे कि अनलोडर से सावधानीपूर्वक गन्ना उतरवाया जा सके एवं ट्रक को कोई क्षति न हो।
- 17.0.50 लाख कु0 तक रू0 10000.00, 0.50 से 1 लाख कु0 तक रू0 20000.00 तथा 1 लाख से ऊपर रू0 30000.00 गन्ना आपूर्ति वाले क्रय केन्द्रों हेतु धरोहर राशि प्रति क्रय केन्द्र ऑनलाइन या बैंक में जमा की जायेगी। जमा की गयी धरोहर धनराशि पर कोई ब्याज देय नहीं होगा।
- 18.ई—निविदा प्रतिभाग करने के लिये किसी भी निविदादाता / गन्ना ढुलाई ठेकेदार के पास प्रति क्रय केन्द्र स्वयं के कम से कम दो ट्रक होना अनिवार्य है अन्यथा कि स्थिति में वह ई—निविदा में प्रतिभाग करने हेतु अर्ह नहीं माने जायेगे। प्रत्येक क्रय केन्द्रो पर ई निविदा में दिये गये द्रकों की संख्या से कम द्रक नहीं होना चाहिए। सम्बन्धित द्रकों के अधिकार पत्र जमा कराना होगा।
- 19.गत वर्षों में इस चीनी मिल समिति में गन्ना ढुलाई करने वाले जिन गन्ना ढुलाई ठेकेदारों का कार्य संतोषजनक नहीं रहा है, उन्हें परिवहन का ठेका नहीं दिया जायेगा। यदि उनके द्वारा निविदा दी जाती है तो उसपर विचार नहीं किया जायेगा।
- 20.परिवहन ठेकेदार को अपने पास उपलब्ध ट्रकों, स्वामित्व, अभिलेखों तथा ट्रकों की संख्या एवं अन्य उपलब्ध होने वाले ट्रकों से सम्बन्धित अधिकार पत्र साक्ष्य के रूप में जमा करने होंगे तथा अद्यावधिक टैक्स भुगतान की रसीद की छायाप्रति जमा करनी होगी।
- 21.ठेकेदार से आयकर की कटौती निर्धारित दर से गन्ना परिवहन के पाक्षिक बिलों से नियमानुसार की जायेगी। परिवहन ठेकेदारों को पैन नंबर भी उपलब्ध कराना अनिवार्य होगा।
- 22. ठेकेदार का उत्तरदायित्व होगा कि अपने मजदूरों / ट्रकों के चालकों / परिचालक आदि को उसके वेतन का भुगतान नियमानुसार करेगा तथा भविष्यनिधि कटौती नियमान्तर्गत की जायेगी तथा उक्त के अवलोकन में यदि कोई वैधानिक कार्यवाही / पैनाल्टी होती है तो उसकी जिम्मेदारी परिवहन ठेकेदार की होगी।
- 23.गन्ना ढुलाई ठेकेदार अपनी लेबर व कर्मचारियों का पंजीकरण सम्बन्धित श्रम कार्यालय में करायेगा तथा क्रय केन्द्र पर लेबर के ठहरने का प्रबन्ध सम्बन्धित गन्ना परिवहन ठेकेदार द्वारा किया जायेगा. जिसके रख रखाव की जिम्मेदारी परिवहन ठेकेदार की होगी।
- 24.गन्ना ढुलाई, उतराई व भराई में नियोजित की जाने वाली लेबर व कर्मचारियों के वेतन आदि के भुगतान की पूर्ण जिम्मेदारी गन्ना परिवहन ठेकेदार की होगी एवं किराये पर लिये द्रको का समय पर भुगतान ठेकेदार की जिम्मेदारी होगी।
- 25.गन्ना ढुलाई दरें तय होने के बाद यदि डीजल की दरों में वृद्धि / कमी होती है तो निर्धारित दरो पर इसका कोई प्रभाव नहीं पड़ेगा।
- **26.**डीजल की व्यवस्था स्वयं परिवहन ठेकेदार को करनी होगी। मिल समिति से डीजल नहीं दिया जायेगा।
- 27. ठेकेदार अथवा चालक / परिचालक गन्ना विभाग से सम्बन्धित डाक आवश्यकता पड़ने पर मिल से क्रय केन्द्र तथा क्रय केन्द्र से मिल तक लाने हेतु उत्तरदायी होगा। डाक मिल / गन्ना कार्यालय के किसी जिम्मेदार कर्मचारी को हस्ताक्षरोपरान्त ही दी जायेगी।
- 28.क्रय केन्द्र पर साप्ताहिक अवकाश, चीनी मिल में कोई अभियान्त्रिक खराबी, सामान्य सफाई, हड़ताल अथवा अनोपेक्षित कारणों से यदि चीनी मिल कुछ समयाविध के लिये बन्द होती है तो ऐसे समय में भी क्रय केन्द्र पर ट्रक तथा लेबर उपलब्ध रहेगी, इसके लिये चीनी मिल कोई अतिरिक्त भुगतान गन्ना परिवहन ठेकेदार को नहीं करेगी।
