For uploading, the bidder should click "Browse" button against each document label in Technical and Financial schedules/packets and then upload the relevant PDF/XLS files already prepared and stored in the bidder's computer. The required documents for each document label of Technical (Fee details, Qualification details, e-Bid Form and Technical Specification details) and financial (e-Bid Form and Price Schedule/BOQ) schedules/packets can be clubbed together to make single different files for each label.

#### 17 Late e- H d

17.1 The server time indicated in the Bid Management window on the e-Procurement website <a href="http://etender.up.nic.in">http://etender.up.nic.in</a> will be the time by which the e-Bid submission activity will be allowed till the permissible date and time scheduled in the e-tender. Once the e-Bid submission date and time is over, the bidder cannot submit his/her e-Bid Bidder has to start the Bid Submission well in advance so that the submission process passes off smoothly. The bidder will only be held responsible if his/her e-Bid is not submitted in time due to any of his/her problems/faults, for what so ever reason, during e-Bid submission process.

- A-2 The bidder's names and the presence or absence of requisite e-Bid security and such other details as the MIII at its discretion may consider appropriate will be announced at the opening. #### 21 Evaluation of technical e- Hi d and Evaluation Criteria

- 22.2 No additional payments shall be made for completion of any contractual obligation beyond the quoted prices. If the supplier does not accept the correction of errors if any, its e-Bd shall be rejected and its e-Bd security may be forfeited.
- 22.3 No weight age/preference shall be given to the bidder quoting any higher technical specifications against the technical specifications of the items asked in the e-tender.
- 22.4 The Mill's evaluation of a Financial bid shall be based in terms of lowest rate quoted including all taxes, duties & other expenses.
- The Financial Bids will be opened by Tender Evaluation committee (TEC) in the presence of Bidders" representatives (only one) who choose to attend the Financial Bid opening on date and time to be communicated to all the technically qualified Bidders. The Bidder's representatives who are present shall sign a register evidencing their attendance.

The name of Bidder, Bid Prices etc shall be announced at the meeting. The commercial quotes of the lowest Bidder shall be notified as L-1. The Quantity offered by the L-1 shall be first taken into consideration. The bidders are required to give their lowest rates in the tenders, though generally negotiation will not be held but if required then it will be done with the lowest bidder (L-1) unit wise.

- a) In case L-1 offers to complete work quantity and is assessed to have the adequate capacity to complete work quantity as per the work schedule by the Tender Evaluation committee (TEC) then L-1 shall be contracted to execute the complete work order.
- b) In case L-1 offers to work partial order quantity and is assessed to have adequate capacity to work the offered partial order quantity as per the schedule by the Tender Evaluation committee (TEC) then the L-1 bidder shall be contracted to work the reduced quantity (which shall be more than the guaranteed minimum quantity) and rest of the quantity shall be allotted to subsequent bidder(s) provided the successful Bidder(s) are ready to offer the quantity at the rates quoted by L-1.
- c) The quantity resulting from the split as mentioned above in case (b) shall be offered to the successful Bidder(s) after the assessment by the TEC interms of their capacity to manufacture and supply.
- d) In case L-1 backs out, the RFP shall be cancelled & Bids shall be invited again L-1 shall however be blacklisted from participating in any future bidding and are liable for legal action taken by Bisalpur Chini Mill.

#### 23 Contacting the Purchaser

#### (D) A WARD OF CONTRACT

#### 24 Award Criteria

- 24.1 The Mill will determine to its satisfaction whether the bidder(s) that is selected as having submitted the lowest rate (L-1) evaluated responsive bid meets the criteria specified in ITB Clause 10.2, and is qualified to perfor much contract satisfactorily.
- 24.2 Subject to ITB Clause 26, the Mill will award the contract to the lowest rate (L-1) evaluated successful Bidder whose bid has been determined to be responsive to all the conditions of the contract and meeting the Technical specification and qualification requirement of the Bidding Document.

#### 25 Mll's right to vary Quantities at the Time of Award

- 25.1 The Mill reserves the right at the time of Contract award to increase or decrease the quantity of goods and services originally specified in the Schedule of Requirements without any change in unit price or other terms and conditions, depending upon the requirement of end-customer. The Mill may also increase or decrease the quantity even after a ward of contract up to the validity period of E-bid
- 25.2 If any taxes/duties are increased/ decreased by the Government during the contract period, the same shall be adjusted mutually after submitting the proof by the successful bidder to the M11.

#### 26 Mll's right to accept any e- H d and to reject any or all e- H ds

26.1 The General Manager reserves the right to accept or reject any e-Bid, and to annul the e-Bid process and reject all e-Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

#### 27- Notification of Award

27. 1 The MIll will notify the successful bidder in writing by letter/e-mail/fax, that its e-Bid has been accepted. Nor mally it will be informed within 30 days after opening of E-commercial/financial bid except in unavoidable circumstances.

#### 28- Signing of Contract

28.1 At the same time as the Mill notifies the successful bidder that his e bid has been accepted, the mill will send the bidder the work order/contract for m provided in the

e-bid documents, incorporating all conditions of the agreement between the parties i.e. mill & successful bidder.

28.2 Within 07 days of receipt of the contract form, the successful bidder shall execute, sign & date the work order/contract & returned it to the mill.

#### 29- Performance/ Work Security

No interest will be paid on EMD. The EMD deposited with Bisalpur Chini Millshall be subjected to timely & satisfactory work.

#### SECTI ON II: CONDITIONS OF E-Tender/CONTRACT (CO

Only Reputed Contractors fulfilling the required conditions of tender document are eligible to participate in the tender.

#### 1- Pri ce

- I. The price should be quoted by the bidders on Ex Mill. This will include basic price, and TDS as per rule, Excluding CST.

#### (iii) Fail ure to Completed work and risk dause:-

#### 6. Variation

The Order do not provide any right to contractors for a particular quantity and the M11 may vary the quantity as per assessment of requirement and also change the schedule in exigency without giving any notice to the Contractors.

#### 7. **Negotiation**

Nor mally negotiation of rate shall not be done, if required negotiation of rate can be done with L-1 bidder. The propriet or/partner of the bidder shall either be present personally or depute their Seni or Executive capable of taking spot decision.

#### 8. Arbitration

Any dispute arising between the Mill and the Contractors shall be referred to a sole Arbitrator. The District Magistrate, Pilibhit will act as sole arbitrator under the Arbitration and conciliation Act, whose decision shall be final & binding on both the party.

- 9. In case of non compliance of the conditions of the order the General Manager of Bisalpur Chini Mill shall have the power to rescind, cancel and annul the contract, bet ween the Mill and the Contractor apart from black-listing the Contractor, and in that event, the sum deposited towards security shall be forfeited and the Contractor shall be further liable to pay actual a mount of loss and damages as provided in Indian Contract Act to Bsalpur Ksan Sahkari Chini Mills Itd., Hsalpur to the extent the same exceeds the security money.
- 10. The bidders who are a warded with the order shall be done work in mill society and in no case they shall be allowed to appoint their sub-contractor for work.
- 11. In case of any dispute between the Contractor and MIII the Hon'ble Allahabad High Court of judicature at Lucknow and Courts sub-ordinate there to of the District in which the mill is situated shall alone have jurisdiction to the exclusion of all other courts.
- 12. In complete tender or those without the prescribed EMD may be rejected.

- 13. The Contractor should be registered with the Excise department / GST so that they may provide CENVAT FACILITY for the items on which the same is available. They will provide all necessary documents such as Excise Invoice etc to our mill society for enabling them to daim CENVAT FACILITY from the Excise Department wherever applicable.
