- 15.8 Mll reserves the right to cancel any or all e-B ds without assigning any reason.

16- Deadline for Submission of e- H d

- e-Bid (Technical and Financial) must be submitted by the bidders at e-Procurement website http://etender.up.nic.in not later than the date as mentioned on page 4 (as the server time displayed in the e-Procurement website).
- 16.2 The Mill may, at its discretion, extend this deadline for submission of e-Bid by a mending the e-Bid document in accordance with ITB Clause 4, in which case all rights and obligations of the Purchaser and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

17 Late e- H d

17.1 The server time indicated in the Bid Management window on the e-Procurement website http://etender.up.nic.in will be the time by which the e-Bid submission activity will be allowed till the permissible date and time scheduled in the e-tender. Once the e-Bid submission date and time is over, the bidder cannot submit his/her e-Bid Bidder has to start the Bid Submission well in advance so that the submission process passes off smoothly. The bidder will only be held responsible if his/her e-Bid is not submitted in time due to any of his/her problems/faults, for what so ever reason, during e-Bid submission process.

18 Withdrawal and Resubmission of e- Hid

The bidder's representatives who are present shall sign a register evidencing their attendance. In the event of the specified date of e-Bid opening being declared a holiday for the Mill, the e-Bids shall be opened at the appointed time and place on the next working day.
- A-2 The bidder's names and the presence or absence of requisite e-Bid security and such other details as the MIII at its discretion may consider appropriate will be announced at the opening. The name of such bidders not meeting the Technical Specifications and qualification requirement shall be notified subsequently.
- A-3 The Mill will prepare minutes of the e-Bid opening.
- A-4 The General Manager reserves the right to post pone the date and time of opening of Technical & Financial E-Bid in unavoidable circumstances and all the bidders will be informed.

19(B) Opening of Financial e- H d

B 1 After evaluation of technical e-Bid, the Mill shall notify those bidders whose technical e-Bids were considered non-responsive to the Conditions of the Contract and not meeting the technical specifications and Qualification Requirements indicating that their financial e-Bids will not be opened. The Mill will

20 Clarification of e-Bld

20.1 During evaluation of e-Bid, the Mill may, at its discretion, ask the bidder for a clarification of his/her e-Bid. The request for clarification and the response shall be in writing.

21 Eval uation of technical e- H d and Eval uation Criteria

The Mill will examine the e-Bid to determine whether they are complete, whether they meet all the conditions of the Contract, whether required e-tender fee, e-Bid EMD and other required documents have been furnished, whether the documents have been properly digitally signed, and whether the e-Bids are generally in order. Any e-Bid or e-Bids not fulfilling these requirements shall be rejected.

22 Financial Evaluation and Comparison of e-Bld

- 22.1 The Mill will evaluate and compare the financial rates of individual items quoted in the price schedule/BOQ of e-Bids of those bidders whose technical e-Bids are found responsive as per the conditions of the e-tender only for those items of the bidders which have been technically accepted by the Mill.
- 22.2 No additional payments shall be made for completion of any contractual obligation beyond the quoted prices. If the supplier does not accept the correction of errors if any, its e-Bd shall be rejected and its e-Bd security may be forfeited.
- 22.3 No weight age/preference shall be given to the bidder quoting any higher technical specifications against the technical specifications of the items asked in the e-tender.
- 22.4 The Mill's evaluation of a Financial bid shall be based in terms of lowest rate quoted including all taxes, duties & other expenses.
- The Financial Bids will be opened by Tender Evaluation committee (TEC) in the presence of Bidders" representatives (only one) who choose to attend the Financial Bid opening on date and time to be communicated to all the technically qualified Bidders. The Bidder's representatives who are present shall sign a register evidencing their attendance.

The name of Bidder, Bid Prices etc shall be announced at the meeting.

The commercial quotes of the lowest Bidder shall be notified as L-1. The Quantity offered by the L-1 shall be first taken into consideration.

The bidders are required to give their lowest rates in the tenders, though generally negotiation will not be held but if required then it will be done with the lowest bidder (L-1) unit wise.

- a) In case L-1 offers to complete work quantity and is assessed to have the adequate capacity to complete work quantity as per the work schedule by the Tender Evaluation committee (TEC) then L-1 shall be contracted to execute the complete work order.
- b) In case L-1 offers to work partial order quantity and is assessed to have adequate capacity to work the offered partial order quantity as per the schedule by the Tender Evaluation committee (TEC) then the L-1 bidder shall be contracted to work the reduced quantity (which shall be more than the guaranteed minimum quantity) and rest of the quantity shall be allotted to subsequent bidder(s) provided the successful Bidder(s) are ready to offer the quantity at the rates quoted by L-1.
- c) The quantity resulting from the split as mentioned above in case (b) shall be offered to the successful Bidder(s) after the assessment by the TEC interms of their capacity to manufacture and supply.
- d) In case L-1 backs out, the RFP shall be cancelled & Bids shall be invited again L-1 shall however be blacklisted from participating in any future bidding and are liable for legal action taken by Bisalpur Chini Mill.
- 23 Contacting the Purchaser
- 23.1 Subject to ITB Clause 20, no bidder shall contact the Mill on any matter relating to his/her e-Bid, from the time of the e-Bid opening to the time the Contract is

- a warded. If the bidder wishes to bring additional information to the notice of the MII, he/she can do so in writing
- 23.2 Any effort by a bidder to influence the Mill in its decisions on e-Bid evaluation, e-Bid comparison or contract a ward may result in rejection of the bidder's e-Bid

(D) A WARD OF CONTRACT

24 Award Griteria

- 24.1 The Mill will determine to its satisfaction whether the bidder(s) that is selected as having submitted the lowest rate (L-1) evaluated responsive bid meets the criteria specified in ITB Clause 10.2, and is qualified to perform the contract satisfact orily.
- 24.2 Subject to ITB Clause 26, the Mill will award the contract to the lowest rate (L-1) evaluated successful Bidder whose bid has been determined to be responsive to all the conditions of the contract and meeting the Technical specification and qualification requirement of the Bidding Document.

25 Mll's right to vary Quantities at the Time of Award

- 25.1 The Mill reserves the right at the time of Contract award to increase or decrease the quantity of goods and services originally specified in the Schedule of Requirements without any change in unit price or other terms and conditions, depending upon the requirement of end-customer. The Mill may also increase or decrease the quantity even after a ward of contract up to the validity period of E-bid
- 25.2 If any taxes/duties are increased/ decreased by the Government during the contract period, the same shall be adjusted mutually after submitting the proof by the successful bidder to the M11.

26 Mll's right to accept any e- H d and to reject any or all e- H ds

26.1 The General Manager reserves the right to accept or reject any e-Bid, and to annul the e-Bid process and reject all e-Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

27- Notification of Award

27.1 The MIII will notify the successful bidder in writing by letter/e-mail/fax, that its e-Bid has been accepted. Nor mally it will be informed within 30 days after opening of E-commercial/financial bid except in unavoidable circumstances.

28- Signing of Contract

- 28.1 At the same time as the Mill notifies the successful bidder that his e bid has been accepted, the mill will send the bidder the work order/contract form provided in the e-bid documents, incorporating all conditions of the agreement between the parties i.e. mill & successful bidder.
- 28.2 Within 07 days of receipt of the contract form, the successful bidder shall execute, sign & date the work order/contract & returned it to the mill.

29- Performance/ Work Security

No interest will be paid on EMD. The EMD deposited with Bisalpur Chini Mill shall be subjected to timely & satisfactory work.

SECTI ON II: CONDI TI ONS OF E Tender/ CONTRACT (CO)

Only Reputed Contractors fulfilling the required conditions of tender document are eligible to participate in the tender.

1- Pri ce

- I. The price should be quoted by the bidders on Ex Mill. This will include basic price, and TDS as per rule, Excluding OST.
- II. The supplier is required to submit the relevant documents to avail CST benefit.
- III. The final rates/discount mentioned in the tender shall remain firm for the crushing season 2024-25 i.e. up to 30-11-2025.
- IV. Any change in the rate of duty, Taxes etc may be accepted provided documentary proof of the same is submitted for approval.
- V. For concessional Formif any shall be provided by the Mill against CST whichever is applicable.

2- Earnest money

Each bidder should submit a bank draft of a nationalized bank for Rs. 50000/- (Rs Fifty Thousand only) in favour of Bsalpur Kisan Sahkari Chini Mlls Itd, Bisalpur representing earnest money. The tenders without earnest money as above shall not be entertained.

4. SANCTI TY

5. Work & Penalty:

- (ii) In case the mill society accept late deliveries, the liquidated damages for delayed delivery @ of 1.0% per week for the unsupplied part of material upto One Week. If the supply delayed upto 2 weeks, penalty will be 5% of the total cost. If the supply delayed upto 3 weeks, penalty will be 10% of the total cost may be charged by the concerned mill society.

(iii) Fail ure to Completed work and risk dause:-

If the contract or fails to complete the work in accordance with the terms and conditions as provided in the order within the time stipulated the sugar factory shall at the risk and cost of contractor and without any notice or reference to him be entitled to complete the work (of the same specifications) from any other source and at such price as the sugar factory shall in their sole discretion think fit and if such price shall exceed the rate set out in the order, the contractors shall be liable to pay the sugar factory, the difference between the price at which work by the sugar factory and at the price set out in the order in addition to penalty and damages as set out in the order

6. Vari ati on

The Order do not provide any right to contractors for a particular quantity and the M11 may vary the quantity as per assessment of requirement and also change the schedule in exigency without giving any notice to the Contractors.

7. **Negotiation**

Nor mally negotiation of rate shall not be done, if required negotiation of rate can be done with L-1 bidder. The propriet or/partner of the bidder shall either be present personally or depute their Seni or Executive capable of taking spot decision.

8. Arbitration

Any dispute arising between the Mill and the Contractors shall be referred to a sole Arbitrator. The District Magistrate, Pilibhit will act as sole arbitrator under the Arbitration and conciliation Act, whose decision shall be final & binding on both the party.

- 9. In case of non compliance of the conditions of the order the General Manager of Bisalpur Chini Mill shall have the power to rescind, cancel and annul the contract, bet ween the Mill and the Contractor apart from black-listing the Contractor, and in that event, the sum deposited towards security shall be forfeited and the Contractor shall be further liable to pay actual amount of loss and damages as provided in Indian Contract Act to Bsalpur Ksan Sahkari Chini Mils Itd, Bsalpur to the extent the same exceeds the security money.
- 10. The bidders who are a warded with the order shall be done work in mill society and in no case they shall be allowed to appoint their sub-contractor for work.
- 11. In case of any dispute between the Contractor and Mill the Hon'ble Allahabad High Court of judicature at Lucknow and Courts sub-ordinate there to of the District in which the mill is situated shall alone have jurisdiction to the exclusion of all other courts.
- 12. In complete tender or those without the prescribed EMD may be rejected.

- 13. The Contractor should be registered with the Excise department / G S T so that they may provide CENVAT FACILITY for the items on which the same is available. They will provide all necessary documents such as Excise Invoice etc to our mill society for enabling the mto claim CENVAT FACILITY from the Excise Department wherever applicable.
- 14. If the rates stipulated in the order of the Mill society are higher in comparison to the Contractor made by your firm to other sugar factories of U.P., the amount due to such rate difference is recoverable from the Contractor. Charging of higher rates in comparison to other public undertaking/Private sector will also make the Contractor (bidder) liable for cancellation of rate contract together with considering black listing their firm and forfeiting the security money/EMD
- 15. The Mill reserves the right to reject any or all tenders without assigning any reason. The Mill also reserves the right to a mend or altogether change the terms & conditions in the overall interest of the Organization before finalization of the order.
- 16. The bidder should mention the guarantee / warranty period of work to our mill society. In case the work fails within this stipulated period, the same shall be done by the Contractor on free of cost basis.
