- 15.6 The bidder should click "Encrypt" next for successfully encrypting and uploading of required documents. During the above process, the e-Bid documents are digitally signed using the DSC of the bidder and then the documents are encrypted/locked

- electronically with the DSC's of the bid openers to ensure that the e-Bid documents are protected, stored and opened by concerned bid openers only.

21 Eval uation of technical e- H d and Eval uation Criteria

- 22.2 No additional payments shall be made for completion of any contractual obligation beyond the quoted prices. If the supplier does not accept the correction of errors if any, its e-B d shall be rejected and its e-B d security may be forfeited.
- 22.3 No weight age/preference shall be given to the bidder quoting any higher technical specifications against the technical specifications of the items asked in the e-tender.
- 22.4 The Mill's evaluation of a Financial bid shall be based in terms of lowest rate quoted including all taxes, duties & other expenses.
- The Financial Bids will be opened by Tender Evaluation committee (TEC) in the presence of Bidders" representatives (only one) who choose to attend the Financial Bid opening on date and time to be communicated to all the technically qualified Bidders. The Bidder's representatives who are present shall sign a register evidencing their attendance.
 - The name of Bidder, Bid Prices etc shall be announced at the meeting
 - The commercial quotes of the lowest Bidder shall be notified as L-1. The Quantity offered by the L-1 shall be first taken into consideration.
 - The bidders are required to give their lowest rates in the tenders, though generally negotiation will not be held but if required then it will be done with the lowest bidder (I-1) unit wise.

- 23 Contacting the Purchaser

- 23.2 Any effort by a bidder to influence the Mill in its decisions on e-Bid evaluation, e-Bid comparison or contract a ward may result in rejection of the bidder's e-Bid

(D) AWARD OF CONTRACT

24 Award Giteria

- 24.1 The Mill will determine to its satisfaction whether the bidder(s) that is selected as having submitted the lowest rate (L-1) evaluated responsive bid meets the criteria specified in ITB Clause 10.2, and is qualified to perform the contract satisfact orily.
- 24.2 Subject to ITB Clause 26, the Mill will award the contract to the lowest rate (L-1) evaluated successful Bidder whose bid has been determined to be responsive to all the conditions of the contract and meeting the Technical specification and qualification requirement of the Bidding Document.

25 Mll's right to vary Quantities at the Time of Award

- 25.1 The Mill reserves the right at the time of Contract award to increase or decrease the quantity of goods and services originally specified in the Schedule of Requirements without any change in unit price or other terms and conditions, depending upon the requirement of end-customer. The Mill may also increase or decrease the quantity even after a ward of contract up to the validity period of E-bid
- 25.2 If any taxes/duties are increased/ decreased by the Government during the contract period, the same shall be adjusted mutually after submitting the proof by the successful bidder to the M11.

26 Mll's right to accept any e- H d and to reject any or all e- H ds

26.1 The General Manager reserves the right to accept or reject any e-Bid, and to annul the e-Bid process and reject all e-Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

27- Notification of Award

27.1 The MIII will notify the successful bidder in writing by letter/e-mail/fax, that its e-Bid has been accepted. Nor mally it will be informed within 30 days after opening of E-commercial/financial bid except in unavoidable circumstances.

28- Signing of Contract

- 28.1 At the same time as the Mill notifies the successful bidder that his e bid has been accepted, the mill will send the bidder the work order/contract form provided in the e-bid documents, incorporating all conditions of the agreement between the parties i.e. mill & successful bidder.
- Whin 07 days of receipt of the contract form, the successful bidder shall execute, sign & date the work order/contract & returned it to the mill.

29- Performance/ Work Security

No interest will be paid on EMD. The EMD deposited with Bisalpur Chini Mill shall be subjected to timely & satisfactory Work.

SECTI ON II: CONDI TI ONS OF E-Tender/ CONTRACT (CO)

Only Reputed Contractors fulfilling the required conditions of tender document are eligible to participate in the tender.

1- Price

The price should be quoted by the bidders on Ex - Mill. This will include basic price, & TDS as per rule, Excluding CST.

If the contractor fails to complete the job work in accordance with the terms and conditions as provided in the order within the time stipulated the sugar factory shall

at the risk and cost of contractor and without any notice or reference to him be entitled to complete the job work (of the same specifications) from any other source and at such price as the sugar factory shall in their sole discretion think fit and if such price shall exceed the rate set out in the order, the contractors shall be liable to pay the sugar factory, the difference bet ween the price at which Job work by the sugar factory and at the price set out in the order in addition to penalty and damages as set out in the order

10. Variation

The Order do not provide any right to contractors for a particular quantity and the M11 may vary the quantity as per assessment of requirement and also change the schedule in exigency without giving any notice to the Contractors.

11. **Negotiation**

Nor mally negotiation of rate shall not be done, if required negotiation of rate can be done with L-1 bidder. The propriet or/partner of the bidder shall either be present personally or depute their Seni or Executive capable of taking spot decision.

12 **Arbitration**

Any dispute arising between the Mill and the Contractors shall be referred to a sole Arbitrator. The District Magistrate, Pilibhit will act as sole arbitrator under the Arbitration and conciliation Act, whose decision shall be final & binding on both the party.

- 13. In case of non compliance of the conditions of the order the General Manager of Bisalpur Chini Mill shall have the power to rescind, cancel and annul the contract, bet ween the Mill and the Contractor apart from black-listing the Contractor, and in that event, the sum deposited towards security shall be forfeited and the Contractor shall be further liable to pay actual amount of loss and damages as provided in Indian Contract Act to Bsalpur Ksan Sahkari Chini Mils Itd., Bsalpur to the extent the same exceeds the security money.
- 14. The bidders who are a warded with the order shall be done Feeding work in mill society and in no case they shall be allowed to appoint their sub-contractor for the job.
- 15. In case of any dispute between the Contractor and MIII the Hon'ble Allahabad Hgh Court of judicature at Lucknow and Courts sub-ordinate there to of the District in which the mill is situated shall alone have jurisdiction to the exclusion of all other courts.
- 16. In complete tender or those without the prescribed EMD may be rejected.

- 17. The Contractor should be registered with the Excise department / G S T so that they may provide CENVAT FACILITY for the items on which the same is available. They will provide all necessary documents such as Excise Invoice etc to our mill society for enabling the mto claim CENVAT FACILITY from the Excise Department wherever applicable.
- 18. The Mill reserves the right to reject any or all tenders without assigning any reason. The Mill also reserves the right to a mend or altogether change the terms & conditions in the overall interest of the Organization before finalization of the order.
- 19. The bidder should mention the guarantee / warranty period of Feeding work to our mill society. In case the Job work fails within this stipulated period, the same shall be done by the Contractor on free of cost basis.
- 20. The Contractor should give the maximumlife period in years for the work to our Mill.
