Penalty

- **5.1** H-1 bidder fails to submit the amount of scrap's value within 15 days in the bank account of U.P Co-operative sugar federation Lucknow in form Of RTGD/NEFT then the time for the submission of the amount can be extended for one week with penality of 1% as late submission.
