2. If the quantity of the scrap increases or decreases ,Sugar mill will not be responsible for the same.
3. If the quantity of the scrap increases than that increased scrap can be lifted only after seeking the permission from federation & depositing the value of the scrap in federation's bank account & other taxes in sugar mill's bank account.
4. The Tender must be submitted along with the copies of registration with PAN card, Aadhaar Card & Contact Details in Technical Bid.
5. Sold scrap's cutting,loading,extraction & transportation etc will be beared by purchaser.
6. If during the lifting of scrap any mishappening to the purchaser's manpower,the whole responsibility will be of purchaser & the compensation will be beared by the purchaser.
7. After the issue of work order, the earnest money deposited by the external agency will be deposited in the federation as security money, on which no interest will be payable. In case of violation of terms and conditions during the lifting period, the said security money will be forfeited.
8. GST will be paid to the concerned sugar mill as per rules.
9. The Managing Director reserves the right to extend the tender or cancel one or all the tenders without assigning any reason.
10. The external firm will not have the right to transfer/sublet the above work to anyone else. All the letters and bills will be send by the mill management only on the authorized address/email of the external firm.
11. Scrap lifting can be done only during the working days between 08:00am- 05:00pm.Tare weight of registered vehicle for loading/loading/gross weight etc will be under the committee constituted by the sugar mill.If during lifting any machinery part/spare found useful,mill has the right not to sold that particular scrap.

1. Price

The price must be quoted by the bidders for the purchase of the scrap, basic rate, exclusive of GST & other taxes and duties as per government norms.

2. Earnest money

Each bidder should submit Rs. 2,00,000.00 (Rs. Two Lacs only) in favour of Uttar Pradesh Coop.Sugar Factories Federation Ltd. Payable at Lucknow through RTGS/NEFT/NET BANKING. The tenders without earnest money shall not be entertained

Penalty

5.1 H-1 bidder fails to submit the amount of scrap's value within 15 days in the bank account of U.P Co-operative sugar federation Lucknow in form Of RTGD/NEFT then the time for the submission of the amount can be extended for one week with penalty of 1% as late submission. Even after time extension amount of scrap's value is not submitted than EMD will be forfeited for the same.

5.2 If H-1 bidder fails to lift the scarp within the time period mentioned in the lifting order , time period can be extended for the 15 days by the Federation only if the General Manager of the mill allows for the time extension. If scrap is not lifted even after time extension of 15 days than time period can be extended for 30 days by excepting 2% of the remaining scrap per week as ground rent charges.

5.3 If bidder fails to Lift the scrap within time period than the amount of EMD & 25% of the value of remaining scarp will be forfeited.

5. Arbitration

In case of any dispute arising between the parties out of this agreement the same shall be referred to Arbitration by a sole Arbitrator. The Arbitration proceedings shall be conducted in due accordance with the provisions of THE ARBITRATION AND CONCILLATION ACT, 1996. The ARBITRAL AWARD PASSED shall be binding upon both the parties. The seat of Arbitration shall be at LUCKNOW.
